**Declaration**

- I understand that as any of our approved pets become deceased, I/we will not be able to register/purchase another pet without prior permission of the Council, and that approval will be revoked if the said animals prove to be a nuisance.
- If you are Renting or leasing property for which you intend to keep any additional animals, an accompanying letter of approval must be submitted with this application from the landlord/ owner.
- Additional dogs must be desexed.
- I understand that the application fee is non-refundable, and this fee does not guarantee permit approval.
- I am aware that the number of dogs kept at stated property cannot exceed the allowable number of dogs on a property of this size as stated in Council's Local Laws.
- I approve of Council returning my dog (if currently registered) to my property if found wandering for the first time.
- I approve of Council releasing my details (if my dog is currently registered) to another person should they find my dog wandering, for the purposes of that person returning my dog to me.
- I recognise that failure to comply with the Council's Local Laws and any relevant provisions of the Animal Management (Cats and Dogs) Act 2008 may result in Council taking enforcement action against myself.
- I have proper enclosure to keep my dog in to prevent it from wandering or escaping from my land.
- I acknowledge that my dog must always be under effective control if in a public place.
- I will ensure that my dog always wears the prescribed registration tag. Should the registration tag become lost or damaged, I must make an application to Council for a replacement registration tag.
