Annual Dog Registration Fees

- All dogs over twelve (12) weeks of age must be registered this is the Queensland Legislation requirement of the *Animal Management (Cats and Dogs) Act 2008*.
- Refer to Fees and Charges of annual pricing for Dog – Entire and Dog – Desexed.
- Discounts: 50% for payment during the discount period.
- Discounts: 50% for pensioner (additional to early payment).

Microchipping Requirements

Queensland Legislation of the *Animal Management (Cats and Dogs) Act 2008* requires **ALL** dogs born after 1 July 2008 the microchipped by twelve (12) weeks of age.

All dogs given away or sold must be microchipped at point of sale or transfer to new owner. If you have purchased or have been given a dog, it is your responsibility to ensure it is microchipped.

Lost and Found Animals

The Balonne Shire Council's Animal Shelter is open by appointment only, please contact Council on 07 4620 8888 to make an appointment.

When an animal is impounded at the Shelter, Council makes every reasonable effort to contact the registered owner and the secondary contact, to collect the animal. All dogs over twelve (12) weeks old must be registered with Council. Ensuring your dog is microchipped and wearing its Council registration tag is the easiest way to ensure you are reunited with your dog as quickly as possible.

When collecting your animal from the Shelter, **release fees will be charged**. If you have a lost pet, check Council's social media page or contact Council on (07) 4620 8888 to report it missing. Alternatively, if you have found a pet, please report it to Council immediately so that the animal has the best chance of being reunited with its owner.

Declaration:

- I recognise that failure to comply with the Council's Local Laws and any relevant provisions of the *Animal Management (Cats and Dogs) Act 2008*, may result in Council taking enforcement action against myself.
- I have adequate enclosure to keep my dog/s in, and to prevent it from wandering or escaping from my property.
- I acknowledge that my dog/s must always be under effective control and any waste produced to be disposed of appropriately, regardless of if my dog/s is on my property or in a public place.
- I understand that Council's **dog registration tags** are lifelong tags and are not replaced each year. The **annual registration fees** are still applicable however the same registration number will be used for the life of the dog/s.
- I understand that my dog/s must always wear its registration tag.
- I acknowledge that if my dog/s lifetime registration tags become lost or damaged a replacement tag (with a different number) can be purchased at Council's Administration Office in St George, or by calling Council on (07) 4620 8888.
