Making of local law

- 1. Balonne Shire Council (the "Council") has, by resolution dated the 17th day of November 2022, made each of:-
 - (a) Subordinate Local Law No. 1.4 (Installation of Advertising Devices) 2022; and
 - (b) Animal Management (Amendment) Subordinate Local Law (No. 1) 2022; and
 - (c) *Keeping of Animals (Amendment) Subordinate Local Law (No. 1) 2022.*

Local law amended

- 2. Animal Management (Amendment) Subordinate Local Law (No. 1) 2022 amends Subordinate Local Law No. 2 (Animal Management) 2018.
- 3. *Keeping of Animals (Amendment) Subordinate Local Law (No. 1) 2022* amends *Subordinate Local Law No. 1.5 (Keeping of Animals) 2018.*

Local law repealed

4. Subordinate Local Law No. 1.4 (Installation of Advertising Devices) 2022 repeals Subordinate Local Law No. 1.4 (Installation of Advertising Devices) 2018.

Authorising local law

- 5. Local Law No. 2 (Animal Management) 2018 authorises the making of Animal Management (Amendment) Subordinate Local Law (No. 1) 2022.
- 6. Local Law No. 1 (Administration) 2018 authorises the making of Keeping of Animals (Amendment) Subordinate Local Law (No. 1) 2022 and Subordinate Local Law No. 1.4 (Installation of Advertising Devices) 2022.

Purpose and general effect

- 7. The purpose and general effect of:-
 - (a) Subordinate Local Law No. 1.4 (Installation of Advertising Devices) 2022 is to prescribe matters regarding the prescribed activity of the installation of advertising devices including—
 - (i) when section 6(2) of the authorising local law does not apply to particular activities; and
 - (ii) the documents and materials that must accompany an application for an approval for the prescribed activity; and
 - (iii) criteria about which the local government must be satisfied before the local government may grant an approval in respect of the undertaking of the prescribed activity; and
 - (iv) the conditions that must, or will ordinarily, be imposed on an approval for the undertaking of the prescribed activity; and
 - (v) the term of an approval for the undertaking of the prescribed activity; and

- (b) Animal Management (Amendment) Subordinate Local Law (No. 1) 2022 is to-
 - (i) prescribe when the keeping of specified animals is prohibited; and
 - (ii) prescribe when an approval is required in respect of the keeping of specified animals; and
 - (iii) identify town areas for the purposes of the application of the authorising local law; and
- (c) Keeping of Animals (Amendment) Subordinate Local Law (No. 1) 2022 is to—
 - (i) prescribe material that must accompany an application for an approval; and
 - (ii) prescribe additional criteria for the granting of an approval in respect of the keeping of dogs; and
 - (iii) prescribe conditions that will ordinarily be imposed on an approval in respect of the keeping of dogs.

Anti-competitive provision

8. *Subordinate Local Law No. 1.4 (Installation of Advertising Devices) 2022* contains an anti-competitive provision.

Consolidated version of local law

- 9. Council has, by resolution dated the 17th day of November 2022, adopted a consolidated version of each of:-
 - (a) Subordinate Local Law No. 2 (Animal Management) 2018; and
 - (b) Subordinate Local Law No. 1.5 (Keeping of Animals) 2018.
