RATES AND CHARGES 2018/19 - OVERVIEW

Revenue Statement

Council's Revenue Statement for the 2018/19 financial year aims to:

- Assist the community to understand its Budget and rates and charges structure;
- Provide clear information around rate setting to help the community understand the issues;
- Comply with the Local Government Act 2009 and the Local Government Regulation 2012.

The Revenue Statement is developed in accordance with the Revenue Policy 2018/19, which sets out the principles used by Council in setting rates and charges.

Revenue of \$10,446,100 will be generated in 2018/19 through net rates and charges comprised of:

General Rates \$6,396,300
Utility Charges \$3,843,000
Special Rates and Charges \$206,800

There are a number of differential general rates and minimum general rates, which are set based on land usage and other relevant factors.

Utility Charges are made up of Water, Waste Water and Cleansing Charges. There is a Environmental Utility Charge for areas surrounding each township to use Council's Landfill facilities. Mungindi Waste Management and water charges are based on Moree Plains Shire Council charges and no changes were proposed for 2018/19.

Special Rates and Charges are made up of the Thallon Rural Fire Levy, Feral Animal Management Special Rate and Urban Animal Control Special Charge.

Differential General Rates

For the 2018/19 financial year, Council has increased the minimum general rate across all categories by 1% from the previous financial year. Council has also applied a 3% increase across all rating categories to the rate in the dollar. Limitations have continued for some of the differential rating categories due to the volatility of the 2017/18 land revaluation. There have also been some changes to cotton gins, grain silos and petroleum rates in the dollar benchmarked with similar sized local governments. Council has also introduced a number of new categories to recognize changing industries across the Shire, such as sheep feedlots and solar farms.

The net effect of the changes to rates and utilities, and limitations working through, is approximately 6.4% increase in council's rate revenue.

Land Valuations

In accordance with the Land Valuation Act 2010 Council receives land valuations and these valuations are used by Council for rating purposes. A land valuation was completed in 2017 for Balonne Shire and as a result land valuations across the Shire both increased and decreased significantly. Limitations were applied to those rating categories that experienced significant increases in valuation.

Council levies Differential General Rates and the Feral Animal Management Special Rate based on the value of the land as assessed by the Department of Natural Resources, Mines and Energy.

Utility Charges

For the 2018/19 financial year, Council will increase utility charges, by 3%. Council's waste collection contract was renewed in 2017/18 improving Council's door-to-door pick up service from a split-bin service to a weekly general waste and a fortnightly recycle service. The increase recognises the need to fully recover the cost of the service. With the new service, Council has set an extra charge if a ratepayer would like an additional general or recycle service. To assist pensioners, the concession allocated to the cleansing charge, as agreed during community consultation, will continue.

In the 2018/19 financial year, Council will levy the following charges for St George, Dirranbandi, Bollon, Thallon, Hebel and Nindigully where services are available:

- Water Charges including excess and consumption charges;
- Cleansing Charges;
- Waste Water Charges.

Council will also levy the following charges to ratepayers on the Queensland side of the border within the Balonne Shire boundary in Mungindi, on a similar basis to how Moree Plains Shire Council charge their ratepayers on the NSW side. No increase is proposed for 2018/19, consistent with Moree Plains Shire Council's proposal.

Mungindi Waste Charges:

Special Rates and Charges

For the 2018/19 financial year, Council will increase the Thallon Rural Fire Levy by 1.5%. The Urban Animal Management Special Charge will remain at \$21 per assessment. The Feral Animal Special Rate remains unchanged, to produce revenue up to \$170,000 across the applicable rating categories. The Environmental Special Utility Charge remains unchanged at \$50 per assessment.

Discount

For the 2018/19 financial year, Council will allow a discount of 10% for prompt payment of rates for General Rates, Water Charges, Waste Water Charges and Cleansing Charges if all rates and charges, including arrears are paid within 30 days of issue of notice.

Pensioner Rate Concessions

For the 2018/19 financial year, Council will grant a concession on rates for properties owned or occupied by Pensioners. This concession is equal to 100% of the General Rate - up to a maximum of \$150 per year. Council has granted an additional \$20 concession per year for cleansing to owners of qualifying premises. This concession is in addition to the 20% subsidy offered by the State Government (capped at \$200 per annum).

Interest

For the 2018/19 financial year, Council will charge interest at 11% per annum compounding daily on all rates and charges outstanding for sixty (60) days after the date of issue.
